2.2 Proposed Constitution



Draft Amended North West Country Incorporated Constitution

The Incorporated Societies Act 2022 requires a few changes to be made to the North West Country Incorporated constitution, as detailed in the attached draft document. Namely:

- decide whether the Manager should be an officer of the society,
- nominate a contact person (can have up to three) and define how they will be elected or appointed,
- define a procedure for resolving disputes, including providing for how a complaint may be made,
- when minutes are required to be kept at a general meeting, and
- where surplus assets from the society will be distributed in the event of the removal of the society. Must be nominated in the constitution as a not-for-profit. Additional work is to be undertaken on the draft constitution prior to presentation to the executive committee.
 - 1. Provide clarification around the liabilities and duties of an officer.

- 2. Provide consideration for insurance for officers.
- 3. Add a section to the constitution for consideration allowing the Manager to be a named officer.
- 4. All executive committee members are to put forward nominations for a suggested Not For Profit organisation to be named in the constitution.
- 5. Consider a simplified complaints and conflict resolution section that better suits the organisation.

New septic system upgrade is underway however Council insisted works stop for 10 days while a senior officer could attend site to discuss the plans. When Council finally got to site the officer only had questions about the previous design and had no concerns with the newly consented design and allowed works to continue.

Security bollards installation work is slow to progress due to a lack of construction companies available. James sent a link to a good contractor to Robbie.

All copper cables from the rear lighting to the village have been stolen and need replacing. The body corporate is currently looking at ways to complete that work.
