2.2 Kumeu Showgrounds Opportunities



Information Accepted

North West Country Inc is in a position to provide ongoing support to the Kumeu District Agricultural Horticultural Society (KDAHS) which will encourage higher use of the showgrounds, attract more visitors and shoppers to the area, and enable greater economic development.

The BID Manager has met the President and General Manager of the KDAHS across November and January to look at opportunities to bring each organisation benefit.

Opportunities exist to:

- provide 100 branded tote bags to the Kumeu Show 2024 identifying NWCBA as a sponsor (\$700 investment),
- promote the Kumeu Show 2024 on our channels to encourage visitors which in turn may shop in the wider area,
- place our tall flags at the entrance to Kumeu for show day weekend to promote the area and NWCBA,
- encourage local shops to make the most of the showgrounds events to provide 'show day discounts' while we have visitors on our doorstep,
- provide a Kumeu Show 2024 hourly shuttle from Swanson Park n Ride to Kumeu for the weekend. Shuttle tickets are \$10 return and will be sold by the Kumeu Show with funds transferred to us. Cost of shuttle and driver for the weekend is \$1,331.18 and we expect \$500 in income.
- support KDAHS to attract more expos to the area. More opportunities exist as Alexandra Park is closing. Limitations exist around a lack of accommodation in the area. The BID Manager has met with Tataki Auckland Unlimited to seek support to attract major accommodation providers to the area.

Crime Prevention Funds Waimauku

North West Country Incorporated was awarded \$2,000 from Auckland Council, to be used for crime prevention initiatives in our area. This was part of a regional initiative.

Funds must be allocated for use prior to 29 December 2023 or the funds will be returned to Auckland Council.

Waimauku Village have experienced 4 ram-raids over the past years where the double doors at the Fresh choice supermarket have been rammed and severely damaged. This is a significant cost and impacts the insurance premiums of the Waimauku Village Bodycorp and direct costs significantly.

The management board has agreed to allow vulnerable tenants to install bollards as a preventative measure. In the interim Waimauku Village have large concrete blocks providing physical security until design and approval from all property owners is agreed.

Waimauku Village Bodycorp are seeking quotes and design so the Bodycorp can arrange to install bollards on the common property that aesthetically fit well with the environment and village centre design.

The tenants and Bodycorp will be collectively funding this exercise, however it is a huge burden given the costs we have had to endure with the consequences of 4 floods in 5 weeks at the start of 2023.

MOTION

The North West Country Executive Committee commit \$2,000 of crime prevention funds to Waimauku Village Bodycorp to contribute to the installation of security bollards in common areas to prevent crime.
