5) North West Festival

Budget for 2023 Event attached. 2020 Final budget attached as comparison.

Main points:

- Increase in costs of \$36,499.00 from \$195,086.00 in 2020 to \$231,585.00 predicted for 2023
- Main cost increases are; Hunting Lodge +\$17,750 (from \$8400 to \$26,250); Management fee +\$5000 and stage hire +\$3000.
- Income is predicted to increase from \$196,244 to \$275,803 which would create a 'profit' of \$44,217.
- Income is based on 3500 attendees with 500 of those buying early bird tickets.
- Ticket prices would increase by \$10 for early bird and normal tickets, children unchanged.
- The 2020 event had 3000 attendees with 2400 of those being adults tickets.
- If ticket sales for 2023 end up matching those of 2020 then there would be a \$64,000 reduction in sales and the association would not get all of its 'investment' of \$50,000 back.
- Acts will be essential to meet attendee goal.
- Proposed acts are Tami Neilson, Bic Runga, Hollie Smith.
